As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. - (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

required for 2021 and Lead and Copper (tap water) samples were not collected during the required June-September 2021 monitoring period. Samples were

know whether the contaminants were present in your drinking water, and we are unable to tell you whether your health was at risk during that time. The
